### **KOJADI OFFERS BENEVOLENT BENEFIT TO MEMBERS**

---

Kuala Lumpur : Koperasi Jayadiri Malaysia Berhad (KOJADI) has introduced a Members' Benevolence Scheme to provide bereavement benefit to the next of kin of deceased members.

Datuk Khoo Lay Hin, Honorary Secretary of KOJADI said in a statement that the benefit under the scheme is meant to be a token of remembrance.

He said the scheme is open to all qualified members who have paid up or owned a minimum of RM100 shares in KOJADI for at least three full calendar years prior to their demise. "New members will not qualify if death occurs before completion of the minimum three (3) years membership," he added.

Datuk Khoo said, application for the benevolent benefit shall be made in the prescribed form obtainable from KOJADI and submitted together with all relevant supporting documents such as certified copies of NRIC and death certificate or burial certificate to reach KOJADI within 180 days from the occurrence of death. Applications submitted beyond the 180 day period or incomplete applications will not be entertained.

He said the amount of benevolent benefit is minimum RM300.00 for each approved application. The Board of KOJADI may decide such amount of benefit and the mode of payment from time to time

### 自立合作社推出社员抚恤金计划，每已故合格社员家属可获 300 令吉

吉隆坡二十二日讯：自立合作社已推出《社员抚恤金计划》供已故合格社员的家属申请。获批准的每项申请可获 300 令吉的抚恤金。

自立合作社义务秘书拿督邱励兴发表文告说，该社推出此抚恤金计划的宗旨是向已故社员表示纪念和心意。他说，抚恤金的数额为每名已故合格社员 300 令吉或董事会随时决定的数额

他指出，该计划公开予所有合格之社员，即已经缴交以及/或拥有该社最少 100 令吉股金并且社籍已达到至少 3 年者。惟若社籍不足 3 年之新社员逝世，将不能享有该计划的利益。

此外，凡在此计划下享有利益的社员将被视为同意一旦他逝世时，其在本社的股份将转让至被提名者或有关的亲属。

邱励兴补充说，在本计划推行后，社员从其他社员承购、转让或继承的本社股份必须满三年后，方可获计算享有本计划下的抚恤金。

有关抚恤金的申请手续，邱励兴说，所有申请须填妥有关表格，并且连同呈上所有已经确认的辅助文件，譬如身份证及死亡证书或埋葬证书，于死亡发生后 180 天内送达该社。申请表格可向该社索取。没有于死亡发生后 180 天内送达该社的逾期申请，无论任何理由将不受理及不可享受此计划下的利益。不完整的申请表格将一概作废。

成立于 1981 年的自立合作社是国内其中一家最大的合作社，共有社员逾 6 万五千。
